

KUFUNWA UVO OLUBHALWE PHANSI UKUCHITSHIYELWA KWEMIBANDELA YELAYISENSE NJENGOKULANDISA KUKA-SECTION 24(1)(d) OF THE GAS ACT, 2001

Abakwa-National Energy Regulator (NERSA) bayinhlango ezimele esingatha ukusabalalisa igesi/ugesi neyasungulwa ngokomthetho ngokulandisa kwesigaba 3 seNational Energy Regulator Act, 2004 (Act No. 40 of 2004). U-NERSA unikwe igunya lokulawula ugesi, igesi elihamba ngamapayipi kanye nemboni yamapayipi ahambisa uphethiloli ngokwezimiso ze-Electricity Regulation Act, 2006 (Act No.4 of 2006), Gas Act, 2001 (Act No. 48 of 2001 and Petroleum Pipelines

Act, 2003 (Act No.60 of 2003).

Ngokulingana no-section 24(1)(d) weGas Act, 2001, u-NERSA uphakamisa ukuchibiyela ezinye zemizimo noma imibandela yelayisense kulamalayisense alandelayo nanikezwa uSasol Gas Limited ("Sasol Gas") ngaphambi kuka-26 March 2014, ngalesi zizathu ezibekwe lapha ngezansi:
